Did you know?

Essential Oils Can Kill Pathogenic Bacteria

Essential oils derived from medical and aromatic plants contain a wide variety of secondary metabolites that are capable of inhibiting or slowing the growth of bacteria, yeasts and moulds. The presence of different types of aldehydes, phenolics, terpenes and other antimicrobial compounds means that the essential oils are effective against a diverse range of pathogens.

Studies on essential oils obtained from cinnamon, clove, pimento, thyme, oregano and rosemary showed that they possess antimicrobial activity against *Salmonella typhi*, *Staphylococcus aureus* and *Pseudomonas aeruginosa* by damaging the cell wall and membrane, leading to cell lysis, leakage of cell contents and inhibition of proton motive force. In addition, there is an evidence that they effectively kill bacteria without promoting the acquisition of resistance.

Essential oils might be a prospective source of alternative antimicrobial agents and may play an important role in the discovery of new drugs for the treatment of a wide range of pathogenic microorganisms in the near future.

Regulations

Thai FDA Guideline for Cosmetic Advertisement: Hair Perming, Strengthening and Coloring Products

1. A statement or picture conveying the efficacy of product in helping to improve hair condition or not to damage the hair is prohibited, except that the product contains an active ingredient helping protect or nourish the hair with efficiency test support.
2. An advertisement should state or imply that the product has a temporary effect and should advise the consumers to test the product before use in order to find out if they have allergic reaction because it is well known that chemical substances used in this product category have an effect on hair's condition and may cause allergy upon contact.

Remarks: Those claim statements are not related to the name of product type, for example, permanent, semi-permanent and temporary hair color.
